In consideration of the Company accepting the application for credit from the Principal Debtor and for agreeing to supply or continuing to supply goods and / or services on credit to the Principal Debtor, the directors of the Principal Debtor listed in the schedule ('Guarantors') agree with the Company as follows:

1. For the period of this guarantee, the guarantors hereby jointly and severally guarantee the due payment to the company of all monies and interest owing by the Principal Debtor to the company for all such goods and / or services as the company may from time to time supply or have supplied to the Principal Debtor, upon request from the Principal Debtor, upon request from the Principal Debtor.

2. This guarantee shall be continuing guarantee to the company for the whole of the Principal Debtor's indebtedness or liability to the company in respect of goods and / or services supplied to be supplied to the Principal Debtor or upon any other account, howsoever or whensoever arising.

3. 4. Without waiving its right under this Guarantee in any way the Company shall be at liberty, without notice to the Guarantors, at any time and without in any way discharging the Guarantors from liability as guarantors, to grant additional time to the Principal Debtor for payment of invoices and outstanding debts and to accept part payment of invoices and outstanding debts from the Principal Debtor.

5. This guarantee shall not be determined by the death or bankruptcy of any one or more of the Guarantors and shall be binding upon the Guarantors' executors, administration and assigns.

6. All dividends and payments received by the company from the Principal Debtor, whether in liquidation or otherwise, shall be taken and applied by the Company as payments in gross and any right of subrogation to the company which the Guarantors may have against the Principal Debtor shall not arise until the company has received payment in full for the whole of the Principal Debtor's indebtedness and liability to the company.

7. The company may, at any time or times in its absolute discretion, and without giving any notice to the Principal Debtor or the guarantors, refuse further credit or supplies of goods and / or services to the Principal Debtor.

8. If the guarantors give the company not less than thirty (30) days written notice of their desire to be released from this Guarantee and if at the expiration of such period of notice all debts and liabilities of the Principal Debtor to the company have been discharged, then this guarantee shall cease to be of effect.

9. Unless a change of address is received by the company, any notices to be served on the Guarantors concerning any matter relating to this guarantee shall be sufficiently served if posted by registered mail to the guarantors at their personal address listed in the schedule to this guarantee.

10. The guarantors hereby grant authority to the company to enquire about the personal financial history of each guarantor, using commercial credit information services, credit reporting agencies and by obtaining information from banks, financial institutions and referees nominated by the guarantors. For the purposes of enquiring about the financial position of the guarantors each guarantor consents to the company collecting and disclosing personal information, including personal financial information about them.
